3. The expenditure is incurred after observing all the codal formalities and procedures in vogue.
4. The payment of scholarship be made by Payees cheques only on the name of the students.
5. The beneficiaries will have to produce a fresh affidavit declaring there in that he/she belongs to Pahari Speaking Community and his/her parental income does not exceed to Rs 2.50 Lacs per annum.
6. A separate register indicating the names of the students with parentage, residence, Constituency amount paid by Cheque, Cheque No is maintained and a copy of the same be submitted to this office.
